Docket C-06-09S, Short Variance, **Chemical Waste Management**, 35251 Old Skyline Road, Kettleman City, CA. 93239.

Docket C-06-10i, Interim Variance, **Wellhead Power Gates, LLC**, 39950 S. Butte Ave., Huron, CA. 93234. Type of Business: Cogeneration Facility.

Mr. Dodds made a correction to Recommended Condition #10 to read:

WPG shall submit to the District a written report by November 29, 2006, or no later than fifteen days after completion of this variance in accordance with Recommended #1, however should the Central Region Hearing Board grant a Regular Variance to Docket C-06-10R, a summary report shall be submitted in accordance with the timeframe that is established within the Regular Variance.

**Petitioner** – Andrew C. Robertson represented Wellhead Power Gates, LLC.

**Decision** – Board Member Boren made the motion to grant the variance with a comment that the findings could be made with a good cause finding. The variance shall be subject to the twelve recommended conditions with a correction to #10. Seconded by Board Member Waterman and unanimously carried.
