Docket C-05-09S, Short Variance, **Harris Ranch Beef Co.**, 16277 S. McCall Avenue, Selma, CA. 93662 Type of Business: Beef Processing Plant

**Petitioner** – Donnie Shaw represented Harris Ranch Beef Co.

**Decision** – Board Member Schumacher made the motion to grant the variance.
