Petitioner - Bernard Reed represented Algonquin Power Sanger, LLC.

Public Comment – No Public Comment.

Decision – Board Member Waterman made the motion to grant the variance. The required six findings set forth on pages 2, 3 and 4 of the Staff Report were adopted by reference. The variance shall be subject to fourteen recommended conditions set forth on pages 4 and 5 of the Staff Report. Seconded by Board Member Boren and unanimously carried.

The Central Region Hearing Board granted a Short Variance to Docket C-06-04S Algonquin Power Sanger, LLC. The variance shall only be effective for a single, consecutive 2-day period to begin May 1, 2006 and end May 2, 2006, or until compliance is achieved, whichever occurs first. The fourteen recommended conditions will be set forth in the Central Region Hearing Board Order.
