Docket No. C-01-29S, Short Variance, Coalinga Cogeneration Company, 32812 W. Gale Avenue, Coalinga, CA. 93210. Type of Business: Natural Gas-Fired Cogeneration Facility

<u>Petitioner</u> – Rob Hiestand represented Coalinga Cogeneration Company.

Public Comments – No Public Comments.

<u>Decision</u> – The Board reviewed and discussed the required six findings set for on pages 2 and 3 of the Staff Report and concurred that the finding could be made. Mr. Boren made a motion to grant the variance subject to the eleven recommended conditions (with revisions) set forth on pages 3 and 4 of the Staff Report. The motion was seconded by Mr. Azevedo and carried unanimously.

Therefore, the Board granted a Short Variance to Docket No. C-01-29S, Coalinga Cogeneration Company. The variance shall be effective from February 25, 2002 and May 25, 2002 March 25, 2002. The variance is subject to eleven conditions as set forth on pages 3 and 4 of the Staff Report (with revisions to Condition #1 and Condition #2). (Condition #1, The variance shall be effective for a consecutive two-day period between February 25, 2002 and May 25, 2002 March 25, 2002, Condition #2, Relief shall be granted from the District Rules 1080, 2070.7.0, 2201, 4703 and conditions 7, 9, 13 and 15 of PTO ##C-354-2-2). The eleven conditions will be set forth in the Order.
