On May 28, 2008, Hearing Board Vice Chairman, Mr. Gerald Schneider, approved an emergency variance from May 27, 2008 to June 19, 2008. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, 2520, and 4352 and allowed the biomass- fired boiler to continue to operate without a functioning COMS while the COMS was undergoing repair.
