5. The Northern Region Hearing Board approved the following emergency variances orders:

A. Docket N-08-05E – Thermal Energy Development Partnership, LP

On April 4, 2008, Hearing Board Vice Chairman, Mr. Gerald Schneider, approved an emergency variance from April 4, 2008 to April 18, 2008. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, and 2520 and allowed the biomass-fired boiler to continue to operate without a functioning CEMS while the CEMS was undergoing repair.

B. Docket N-08-06E - Pilkington North America, Inc.

On April 28, 2008, Hearing Board Chairman, Mr. Mark Kanai, approved an emergency variance from April 27, 2008 to May 15, 2008. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, 2080, 2520 and 4354 and allowed continued use of the glass-melting furnace while the COMS opacity meter was replaced.
