 The Northern Region Hearing Board approved the following emergency variances orders:

A. Docket N-08-18E – Pilkington North America

On December 17, 2008, Hearing Board Chair, Mr. Mark Kanai, approved an emergency variance from December 16, 2008 to December 26, 2008. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2080, 2520, and 4354 and allowed the continued operation of the secondary glass crushers and cullet conveying system without an operational baghouse and excess visible emissions from that subject baghouse.

B. Docket N-09-01E - Cilion Inc.

On January 9, 2009, Hearing Board Chair, Mr. Mark Kanai, approved an emergency variance from January 9, 2009 to January 19, 2009. Said variance provided relief from specific requirements of District Rules 2010, 2201, and 4623. The variance allowed the continued operation of the ethanol production and load out while the RTO is down for inspection, repairs and/or adjustments.
