5. The Northern Region Hearing Board granted the following emergency variances prior to this Hearing:

A. Docket N-12-10E – Thermal Energy Development Partnership, LP

On May 30, 2012, Hearing Board Chair Mr. Mark Kanai, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from May 29, 2012, to June 25, 2012. Said variance provided relief from specific requirements of District Rules 1080, 2070, and 2520 and allowed for continued operation of the power plant without an operational CEMS for O₂.

B. Docket N-12-12E – Thermal Energy Development Partnership, LP

On July 16, 2012, Hearing Board Vice Chair Mr. Gerald Schneider, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from July 14, 2012, to August 13, 2012.
