5. The Northern Region Hearing Board granted the following emergency variances prior to this Hearing:

A. Docket N-12-13E – E&J Gallo Winery -Brandy

On August 8, 2012, Hearing Board Chair Mr. Mark Kanai, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from August 8, 2012, until August 15, 2012. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 2520 and allowed for the brandy aging operation to continue until the two regenerative thermal oxidizers come back online after a facility wide power outage.

B. <u>Docket N-12-14E</u> – Pilkington North America, Inc.

On September 17, 2012, Hearing Board Chair Mr. Mark Kanai, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from September 15, 2012, until October 15, 2012. Said variance provided relief from specific requirements of District Rules 1080, 2070.7.0, and 2520 and allowed for continued operation of the power plant without an operational CEMS.
