5. The Northern Region Hearing Board has granted the following emergency variances since the April 3, 2013, meeting:

A. Docket N-13-06E – Hilmar Cheese Company

On May 20, 2013, Hearing Board Vice Chair, Mr. Gerald Schneider, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from May 17, 2013, until May 24, 2013. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4306, 4320 and allowed for the continued operation of Boiler #6 without an SCR and with excess NO_X emissions until the SCR is repaired/replaced.

B. <u>Docket N-13-08E</u> – Geer Road Landfill

On June 24, 2013, Hearing Board Vice Chair, Mr. Gerald Schneider, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from June 21, 2013, until July 19, 2013. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520 and allowed for operation of a partial landfill gas collection system and for the postponement of the annual source test for the flare.
