- 10. The Northern Region Hearing Board heard and granted the following emergency variance since the July 5, 2017, Hearing:
 - A. **Docket N-17-16E** Owens-Brockway Glass Containers Inc.

On July 18, 2017, Hearing Board Chair, Mr. Mark Kanai, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from July 18, 2017, and July 20, 2017. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, 4101, 4354, and allowed for the continued operation of the glass melting Furnace B and glass production while the exhaust bypassed the emissions control systems and the CEMS/COMS until the required repair work was performed.
