- 10. The Northern Region Hearing Board heard and granted the following emergency variance since the November 6, 2019, hearing:
 - A. N-19-15E Gallo Glass Company

On November 21, 2019, Hearing Board Vice-Chair, Gerald Schneider, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from November 21, 2019 through December 13, 2019. The variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2520, 4104, and 4354 and for continued glass manufacturing with the specific power of the EP less than 70 milliwatts/acfm with excess emissions of PM_{10} and $SO_{\rm X}$ and to allow excess visible emissions, excess PM_{10} , and excess $SO_{\rm X}$ while the exhaust stream bypasses the EP so that repairs can be performed on the EP. The variance will also allow the continued operation of the four furnaces while bypassing the CEMS.
