A. N-20-07E Gallo Glass Company

On May 20, 2020, Hearing Board Chair, Mark Kanai, acting for and on behalf of the Northern Region Hearing Board, approved an emergency variance from May 13, 2020, through June 11, 2020. The variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2520, 4201, and 4354 and allowed for continued glass manufacturing with the specific power of the electrostatic precipitator less than 70 milliwatts/acfm with excess emissions of PM₁₀.
