The District believes that the required findings can be made and recommends that Stockton CoGen Company be granted the short variance with the conditions on page three and four of the report.

Mr. Kanai asked about the necessity for the variance because the company has an Authority to Construct and there will be no excess emissions during this period to cause a violation. Patrick Houlihan stated that the permit requires that the company always be monitored under CEMS, and while they are installing the analyzer there will be a period of time where they won't have the capability of recording emissions. Patrick Houlihan clarified for Mr. Kanai that the ATC allows them to install new equipment but it doesn't give them a period of time to be without continued emission monitoring.

Mr. Glenn Sizemore, representative of Stockton CoGen Company, stated that he did not have any questions or concerns about the nine recommendations when asked by Mr. Kanai.
