Equilon has requested a regular variance to be effective from December 3, 2008 to June 1, 2009 and if granted, would allow Equilon to continue storing VOC containing fluids in the subject tank that has gaps in excess of the limits established by Rule 4623 and the conditions on the PTO.

The District believes that the six findings can be made and recommends that Equilon Enterprises be granted the regular variance with the conditions on page three and four of the report with the following corrections.

Petitioner's Comments: When asked why variance was necessary for a six-month time period, Christine Davies stated that the part needed to make the repair was coming from an outside vendor and they were at the mercy of supply and demand. She did state that they were expecting repairs to be made in January and six months would not be necessary.
