Gerald Schneider asked if there were any other options for the boiler. He expressed concerns that Rule 4307 was adopted on April 20, 2006 and he can't reasonably conclude due diligence was done by MERCED WWTF. He is concerned about passing this variance.

Mark Kanai responded that he disagreed with Mr. Schneider, stating the MERCED WWTF had no reason to expect to be blocked by MID, and that serious budget issues makes it's very difficult to get funding for such projects.

The District believes that the six findings can be made and recommends that the City of Merced be granted the regular variance with the conditions as stated on pages three, four, and five of the report.
