Patrick Houlihan presented the report with one correction. On page two, paragraph three, it should read as *most* hay companies instead of *no* hay companies.

Green Farms and the GROWERS are requesting a regular variance from November 4, 2009 to May 31, 2010, and if granted would allow rice straw burning of greater than 70% of the total rice acreage when there are no other viable alternatives to burning.

The District believes that the six required findings can be made and recommends that Green Farms and other GROWERS, be granted a regular variance with the conditions as stated on pages three and four of the report.

Mr. Green reiterated the information in the report. Patrick stated the total acreage is less than 8,000. Mr. Green said that if the variance didn't pass, the 30% acreage that couldn't be burned would result in land that wouldn't be put into production. The question of using cogeneration was asked. Mr. Green stated his understanding is that burning rice straw leaves too much silt on the walls at the cogeneration plants. It is very difficult to remove so they stopped burning rice straw.

The question was asked about how many separate growers are involved. Patrick Houlihan is unsure of exact number of growers, but he stated they will have to fill out a rice straw burning request form and meet the criteria listed on page 2 of this report.
