If granted the variance would allow for the subject baghouses to be shut down for the appropriate maintenance.

Patrick Houlihan presented the Staff Report.

Pacific Ethanol Stockton (PES) has requested a short variance from District Rules 2070.7.0, 2201, and 4623, in addition to conditions of the applicable PTOs. The requested short variance would be for a consecutive five day period to occur sometime between February 2, 2011 and March 31, 2011. If granted, the variance would allow the continued ethanol production while the CO₂ scrubber, the vent-gas scrubber and RTO are down to add the de-mister to the CO₂ scrubber.

Mr. Schneider noted two typos in the calculations on page two. They should read: EF VOC (uncontrolled) = 0.0626 lb/1000 gallons of ethanol; and EF VOC (uncontrolled) = 12.52 lb-VOC/1000 gallons of ethanol

Mr. Campbell requested an extension of 30 days, until May 1, 2011, to this variance, to ensure proper installation of the de-mister. Recommendation number one, page four, will now read:

The variance shall be effective for a consecutive five day period to occur sometime between February 2, 2011 and May 1, 2011...

Mr. Houlihan agreed to the 30-day extension and also pointed out that recommendation number eleven on page five will now read:

By May 16, 2011, or no later than 15 calendar days...

Ms. Pagard stated that source testing will be repeated following installation of the de-mister.
