Patrick Houlihan presented the Staff Report.

Pilkington North America (PNA) is requesting a short variance from the requirements of the District Rules 2010, 2070.7.0, 2201, 2520, and 4101, in addition to the

conditions of the subject ATCs and PTOs. The requested short variance period would be for a period to occur between March 14, 2011 and March 31, 2011. If granted, the variance would allow for excess visible emissions while PNA cleans the furnaces ports and flues

Mr. Houlihan pointed out that PNA estimates visible emissions to be no greater than 80% opacity.

Mr. Kanai asked Mr. Wang how long he expected the cleaning process to take. Mr. Wang responded that it could possible take the entire variance period, but it might be a shorter time. It has been many years since this equipment was cleaned.

Mr. Goring asked if most of the emissions would be water vapor. Mr. Wang stated that it would be water vapor and particles.

Mr. Kanai asked if opacity is not a true indication of how much particulate is being omitted. Mr. Houlihan confirmed this statement.

Mr. Schneider asked how any public complaints will be handled in this situation. Mr. Houlihan explained that area inspectors and complainants will be informed that this facility is under variance at this time. Mr. Houlihan confirmed that all complaint calls are logged into a database.

Having decided the petition has met the required findings, on motion of Mr. Scheflo, seconded by Mr. Schneider, unanimously passed, the petitioner was granted a short variance.
