Petitioners: Dennis Leikam

Patrick Houlihan presented the Staff Report.

Musco has requested a short variance from the requirements of District Rules 2010 and 2201, in addition to the applicable conditions of the ATC. The requested short variance period would be from November 9, 2012, until February 6, 2013. If granted,

the variance would allow for the postponement of the start-up compliance source test and the operation of the biomass combustor with excess NOx emissions.

Mr. Leikam thanked Mr. Houlihan for his presentation, he had no further comments.

Mr. Schneider asked how the burn capacity number is obtained and how it's rated for a biomass fueled boiler. Mr. Leikam responded the burner itself is rated at 25MMbtu/hr, however the pit feed system is currently established with gear ratios to ensure pits are blown into the burner up to a 12MMbtu/hr maximum feed. Mr. Schneider asked if the facility only burns olive pits. Mr. Leikam responded the ATC allows for the burning of additional biofuels but for now and the foreseeable future the facility will only burn olive pits. Mr. Schneider requested clarification between the number of days estimated of non-compliance operation with excess emissions at 23 days and the permit period being longer. Mr. Leikam explained the 23 days calculation is based on a worst case scenario. He expressed confidence in completing the project before December 25, 2012.

Having decided the petition has met the required findings, on motion of Dr. Benak and seconded by Mr. Gohring, unanimously passed, the petitioner was granted a short variance.
