LEC has requested an interim variance, to be followed by a regular variance, from the requirements of District Rules 2010, 2070.7.0, 2201, 2520, and 4703 in addition to conditions of the subject PTO and ATC. The requested variance would be for a period to occur between January 16, 2013, and

April 3, 2013, or until the petition for the regular can be heard. If granted, the variance would allow excess hourly CO emissions during start-up and/or tuning events.

Mr. Adkins thanked Mr. Houlihan for the presentation. He added the facility will stay under the start-up daily and quarterly emission limits. He commented the start-up is approximately 24 minutes and the CO emissions exceed the limit for approximately 3-4 minutes.

Mr. Schneider requested clarification regarding the excess emissions when re-starting. Mr. Adkins explained the permit is based on a clock-hour basis; however there would be excess emissions when summing up the two start-ups.

Having decided the petition has met the required findings, on motion of Mr. Scheflo and seconded by Dr. Benak, unanimously passed, the petitioner was granted an interim variance.

B. N-12-19i Interim Musco Family Olive Company 17950 Via Nicolo Tracy, CA 95377

Petitioners: Dennis Leikam

Patrick Houlihan presented the Staff Report.

Musco has requested an interim variance, to be followed by a regular, from the applicable requirements of District Rules 2010 and 2201, in addition to the applicable conditions of the ATC. The requested variance period would be from February 6, 2013, until April 3, 2013. If granted, the variance would allow for the postponement of the start-up compliance source test and the operation of the biomass combustor with excess NO_x emissions.

Mr. Leikam thanked Mr. Houlihan for his presentation. He explained the facility was unable to perform a source test due to mechanical issues.

Having decided the petition has met the required findings, on motion of Dr. Benak and seconded by Mr. Gohring, unanimously passed, the petitioner was granted an interim variance.
