3. APPROVE MINUTES OF December 5, 2012

The Chair asked if there were any comments regarding the Minutes for December 5, 2012. Hearing no comments, the Chair declared the minutes were approved as submitted.

4. Public Hearing

Patrick Houlihan presented the Staff Report.

Hilmar is requesting a short variance from the requirements of District Rules 2010, 2201 and 4311 in addition to conditions of the subject ATC. The requested short variance period would be from January 6, 2013, until April 6, 2013. If granted, the variance would allow for the postponement of the start-up compliance source test of the flare.

Mr. Kummer explained the amount of NOx and CO found in testing. He stated he would be providing a report at the end of the variance period that would quantify the emissions including the quantity of gas burned and the hours of operation.

Dr. Benak asked if the facility is in operation seven days a week. Mr. Kummer responded affirmatively. He explained the facility accepts one million gallons of milk each day and they have no excess storage capacity.

Mr. Houlihan clarified the revisions to the recommendations in the staff report at request of the petitioner:

- 2. Relief shall be granted from the requirements of the applicable sections of District Rules 2010, 2201, and 4311in addition to Condition #9 and #11 of ATC #N-1275-23-7.
- 4. (Renumbered) NOx in excess of the permit condition shall not exceed 200 lbs. over the duration of the variance period.
- 5. (Renumbered) CO in excess of the permit limits shall not exceed 3,500 lbs. over the duration of the variance period.

Mr. Schneider asked if there would be separate limits for VOCs. Mr. Houlihan stated there was no indication the facility will exceed VOC limits. Mr. Kummer added the preliminary testing focused on NOx and CO and there will be very low or no VOCs.

Public Comments: None

Having decided the petition has met the required findings, on motion of Mr. Schneider and seconded by Dr. Benak, unanimously passed, the petitioner was granted a short variance.
