DTE has requested a short variance from the applicable requirements of District Rules 2010 and 2201, in addition to the applicable conditions of the subject ATC. The requested variance period would be from December 4, 2013, until December 31, 2013. If granted, the variance would allow the biomass combustor to exceed the fourth quarter total NO_X limit so that commissioning can continue.

Mr. Schneider asked if the emission mitigation fees will be assessed after the variance is concluded. Mr. Houlihan responded affirmatively.

Ms. Davis explained the facility shut down over the holiday. She added the facility elected to conserve their allowed NO_X pounds and shut down for six days and then restart again.
