SJVUAPCD Northern Region Hearing Board Action Summary Minutes October 1, 2014

CHCF has requested a short variance from applicable requirements of District Rules 1081, 2070, 4305, 4306, and 4320 in addition to the applicable conditions on the subject permits. The requested variance period would be from September 26, 2014, until December 24, 2014.. If granted, the variance would allow for the postponement of the annual compliance source test for the six subject boilers.

Mr. Sahota clarified there is one boiler in operation due to a small demand for heating.

Mr. Albee requested Recommendation 7 regarding monitoring with a portable combustion analyzer on a monthly basis be removed due to safety reasons. He explained the boilers run on natural gas and are fairly new and emissions are minimal. Mr. Houlihan stated the condition is included in the permit issued and suggested discussing the issue with a District Engineer to see if they can have it removed.

Having decided the petition has met the required findings, on motion of Mr. Schneider and seconded by Mr. Gohring, unanimously passed, the petitioner was granted a short variance.
