## 1. <u>Call Meeting to Order</u>

The Chair, Mark Kanai, called the meeting to order at 10:02 a.m.

### 3. Approve Minutes of October 1, 2014

The Chair asked if there were comments regarding the Minutes for October 1, 2014. Hearing no comments, the Chair declared the minutes were approved as submitted.

Patrick Houlihan presented the Staff Report.

Pacific Ethanol has requested a short variance from the applicable requirements of District Rule 2070, 2201, 2520, and 4623 in addition to the applicable conditions of the subject permits. The requested short variance would be from January 8, 2015,

until the end of January 9, 2015. If granted, the variance would allow for continued ethanol fermentation while the RTO and scrubbers are shut down to conduct preventative maintenance.

Mr. Mooring explained there was necessity for an early shut down period and the work will be now be completed at the next scheduled shut down approximately in 9 weeks.

Mr. Houlihan noted the modification in Condition:

 The variance shall be effective for a 48 hour consecutive period within a 90-day period effective January 7, 2015 until the end of April 6, 2015, or until the control equipment is back online at operating conditions, whichever occurs first.

Public Comments: None

Mr. Hofmann expressed concern towards the justification for the second finding adding he did not believe the explanation in the staff report or the oral presentation made clear there is an arbitrary or unreasonable taking of property or closure of a lawful business.

Mr. Houlihan commented the hearing is the appropriate time to discuss any concerns of this nature. Ms. Fierro added if the finding cannot be found to be justified, the approval of the variance would not be appropriate.

Mr. Kanai commented he believed the second finding was justified to be arbitrary and unreasonable due to no provisions in the rules or permit conditions that allow for the control equipment to be shut down for preventative maintenance. Mr. Hofmann commented the sole reason of a business losing money does not support an unreasonable finding. Mr. Kanai added the issue is unreasonable if the facility has no other means of performing preventative maintenance and also the facility is paying for excess emissions.

Mr. Houlihan noted a modification to Finding #2:

2. That, due to conditions beyond the reasonable control of the petitioner, requiring compliance would result in an arbitrary or unreasonable taking of property.

Having decided the petition has met the required findings, on motion of Mr. Schneider and seconded by Mr. Gohring, unanimously passed, the petitioner was granted a short variance.

C. N-14-15S Short Owens-Brockway Glass Containers Inc.

Patrick Houlihan presented the Staff Report.

Owens has requested a short variance from the applicable requirements of District Rules 1080, 2070, 2201, 2520, and 4354, in addition to the applicable conditions of the subject permits. The requested variance period would be from December 23, 2014, until March 22, 2015. If granted, the variance would allow the continued operation of the glass melting furnace and the manufacture of glass until the furnace leak is repaired and the RATA is conducted.

Mr. Schneider asked the amount of damage to the facility from the melted glass. Mr. Howie explained there's no damage if the melted glass stays within the containment area. He added the structure may be damaged if the glass gets around it.

Mr. Howie commented the decision to keep the process running was made to prevent the bricks from collapsing.

Public Comments: None

Having decided the petition has met the required findings, on motion of Mr. Gohring and seconded by Mr. Hofmann, unanimously passed, the petitioner was granted a short variance.
