Mr. Houlihan presented the Staff Report.

Santa Fe is requesting a regular variance from applicable requirements of District Rules 2010, 2201, and 4309, in addition to applicable conditions of the subject permit. The requested variance period would be from October 1, 2016, through October 1, 2017. If granted, the variance would allow Santa Fe to postpone the compliance source test until a sufficient quantity of asphalt is produced in order to perform the compliance source test.

Mr. Hofmann asked if the variance can be retroactive. Mr. Houlihan explained CARB allows the Hearing Board to approve a variance to begin at the date of filing. The variance will allow the facility from accruing a monthly penalty.

Mr. Kanai asked how often the facility is in operation. Mr. Ulm explained the facility just passed 5,000 tons for the entire year and normally the facility produces 100,000 tons per year. Mr. Ulm explained the reason for the decrease is the economy.

Mr. Smedshammer requested clarification on the necessity of 2,000 tons. Mr. Ulm explained the facility must run three 45 minute tests and there's approximately a 15 minute recalibration between each test. The amount of 2,000 tons allows enough run time to complete the tests accurately.

Having decided the petition had met the required findings, on motion of Mr. Hofmann and seconded by Mr. Smedshammer, unanimously passed, the petitioner was granted a regular variance.
