Pacific Ethanol Stockton has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, and 4623 in addition to the applicable conditions of the subject permits. The requested short variance would be for a consecutive 24-hour period to occur sometime January 4, 2017, and January 31, 2017, inclusive. If granted, the variance would allow for continued ethanol fermentation while the RTO and scrubbers are shut down for the proposed work.
