If granted the variance would allow Modesto Irrigation District to postpone the compliance source testing until the unit is returned and source testing is initiated.

Mr. Smith elaborated that on September 5, the test cell unit was tested and results came back higher than acceptable levels. The unit was disassembled, rebalanced the rotator, and reassembled for testing.
