The Board granted an Interim Variance to Docket N-03-09i, Forward Inc., Landfill. The variance is subject to eleven conditions with an amendment to condition # 4 to read: During the variance period, NOx emissions shall not exceed 0.05 lbs/MMBtu. and 57.6 lbs./day. The eleven conditions shall be set forth in the Order.
