On November 14, 2007, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from November 14, 2007, to December 13, 2007. Said variance provided relief from specific requirements of District Rules 2010, 2070, 2201, and 2520, and allowed the continued operation of the subject turbine unit with excess NO_X and CO emissions while performance tests are conducted.

B. Docket S-07-75E - Chevron USA Inc.

On November 8, 2007, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from November 8, 2007, to December 7, 2007. Said variance provided relief from specific requirements o f District Rules 2010, 2070, 2520, and 4623 and allowed the continued operation of the subject tanks without an operational VRS while the VRS compressor is shut down for repair or replacement.
