- 5. The Southern Region Hearing Board approved the following emergency variances orders:
 - A. <u>Docket S-07-45E</u> Kern River Cogeneration Company

On July 5, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 9, 2007, to July 13, 2007. Said variance provided relief from specific requirements of District Rules 2010, 2070.7.0, 2201, and 2520, and allowed the continued operation of the subject turbine with excess NOX and CO emissions during mandatory testing.

B. <u>Docket S-07-46E</u> – Chevron USA Inc.

On July 17, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 18, 2007, to August 16, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 2520 and allowed the operation of the subject emergency flare during a non-emergency event, while CUSA repairs a plugging problem in the VRS discharge gas pipeline. In addition, the variance allowed the tanks to continue operating without a vapor recovery system (VRS) as required.

C. <u>Docket S-07-54E</u> – Sierra Power Corporation

On July 27, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 26, 2007, to August 4, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4352 and allowed the continued operation of the subject boiler system until they are able to receive parts and repair the opacity monitor.
