- 5. The Southern Region Hearing Board approved the following emergency variances orders:
 - A. Docket S-07-28E Chevron USA Inc.

On May 15, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from May 15, 2007, to June 13, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0 and 4623, and allowed continued operation of the subject tanks without an operational VRS while power was curtailed at the Crimson Resource Management facility.

B. Docket S-07-29E - Chevron USA Inc.

On May 24, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from May 30, 2007, to March 31, 2007. Said variance provided relief from specific requirements of District Rules 2010, 2070.7.0, 2201, and 2520, and allowed the continued operation of the subject tanks without an operational VRS while the demister is being removed, cleaned, and maintained.

C. Docket S-07-36E - Chevron USA Inc.

On May 31, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from June 1, 2007, to June 30, 2007. Said variance provided relief from specific requirements of District Rule 4623, and allowed the continued operation of the subject steam generator with NO_X emissions in excess of the Rule limits.

D. <u>Docket S-07-37E</u> - Chevron USA Inc.

On May 31, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from May 31, 2007, to June 28, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 2520 and allowed the operation of Station 1-09 emergency flare during a non-emergency event, and the continued operation of the subject tanks without an operational VRS while a valve on the VRS discharge line was repaired.

E. <u>Docket S-07-39E</u> - Chevron USA Inc.

On June 1, 2007, Hearing Board Member Mr. Hollis Carlile, Chair, approved an emergency variance from June 1, 2007, to June 30, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2520, and 4306, and allowed the continued operation of the subject heater without the catalyst as required.
