 - A. <u>Docket S-07-01E</u> Occidental of Elk Hills

On February 8, 2007, Hearing Board Member Mr. Charles Brehmer, approved an emergency variance from February 7, 2007, to March 8, 2007. Said variance provided relief from specific requirements of District Rules 4101, 4409, 4623, and 47202, and allowed various activities related to resuming production following the pipeline failure.

B. Docket S-07-14E - Chevron USA Inc.

On March 1, 2007, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from February 27, 2007, to March 28, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0 and 4623, and allowed the continued operation of the subject tanks without a vapor recovery system.
