5. The Southern Region Hearing Board approved the following emergency variances orders:

A. Docket S-07-55E – La Paloma Generating Company

On August 14, 2007, Hearing Board Chairman Mr. Hollis Carlile approved an emergency variance from August 9, 2007, to September 7, 2007. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 2520, and allowed the continued operation of the subject turbine unit without a continuously recording fuel gas flow meter as required by permit conditions, and without demonstrating compliance with NH3 emissions as required by the applicable permit condition.

B. Docket S-07-57E – Chevron USA Inc.

On August 15, 2007, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from August 14, 2007, to September 12, 2007. Said variance provided relief from specific requirements of District Rules 2010, 2070.7.0, 2520, and 4623, and allowed the continued operation of the subject tanks without an operational VRS while CUSA shut and repaired or replaced the subject VRS compressor.
