5. The Southern Region Hearing Board approved the following emergency variances orders:

A. Docket S-08-22E – Chevron USA, Inc.

On April 2, 2008, Hearing Board member, Ms. Kimm Wolber, RN, COHN-S approved an emergency variance from April 1, 2008 to April 30, 2008. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4623 and allowed the continual operation of petroleum storage tanks without a VRS while the natural gas line to the steam generators, that incinerate the VRS gas, was repaired.
