A. Docket S-09-38E – Covanta Delano, Inc.

On July 21, 2009, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, CLNC acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from July 18, 2009 to August 16, 2009. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201,

2520, and 4352 and allowed the continued operation of Unit 1 boiler and steam turbine electrical generator without the CEMS in operation.

A. Docket S-09-43E – Chevron USA, Inc.

On August 4, 2009, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, CLNC acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from August 4, 2009 to September 2, 2009. Said variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2520, and 4623 and allowed the subject storage tanks to continue to store VOC containing liquids without an operational vapor recovery system.
