5. The Southern Region Hearing Board approved the following emergency variances orders since the April 8, 2009 Hearing:

A. Docket S-09-26E – North Kern State Prison

On April 14, 2009, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, CLNC acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance for April 16, 2009. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 4702 and allowed the use of an emergency back-up generator during a non-emergency event.

B. Docket S-09-27E – Chevron USA Inc.

On April 14, 2009, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, CLNC acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 13, 2009 to April 20, 2009. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, and 4623 and allowed the continued storage of VOC containing fluids in tanks, at the 8Z NEMU, without an operational vapor recovery system.
