5. The Southern Region Hearing Board granted the following emergency variances orders since the last Hearing:

A. Docket S-10-18E – ExxonMobil Production Company

On March 24, 2010, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board approved an emergency variance from March 24, 2010 to April 23, 2010. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 4623 and allowed for the continued storage of VOC containing liquids in tank T-202 while the tank is opened to atmosphere for repair.

B. Docket S-10-20E – Styrotek, Inc.

On March 31, 2010, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board approved an emergency variance from March 29, 2010 to April 28, 2010. Said variance provided relief from specific requirements of District Rules 2010, 2201, 2520, and 4682 and allowed for the continuation of the expanded polystyrene container operation without the regenerative thermal oxidizer meeting the 99% destruction efficiency.

C. Docket S-10-21E – Styrotek, Inc.

On March 31, 2010, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board approved an emergency variance from April 2, 2010 to May 2, 2010. Said variance provided relief from specific requirements of District Rules 2070, 2520, 4701, and 4702 and allowed for the postponement of the source test until the internal combustion engine is repaired.
