5. The Southern Region Hearing Board granted the following emergency variances since the June 8, 2011, Hearing:

# A. Docket S-11-30E – ExxonMobil Production Company

On June 10, 2011, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from June 14, 2011 to June 15, 2011. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401, 4409, and 4623 and allowed for the continued operation of the subject petroleum storage tanks without an operational vapor recovery system.

# B. <u>Docket S-11-31E</u> – Alon Bakersfield Refining

On June 15, 2011, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from June 17, 2011, to July 17, 2011. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4305, 4306, and 4320 and allowed for the Selas heater 20-H11 to go through an extended start up period beyond the permitted two hour start-up allowance.

## C. <u>Docket S-11-37E</u> – Alon Bakersfield Refining

On July 1, 2011, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from July 1, 2011, to July 30, 2011. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4306, and 4320 and allowed for the Selas heater 20-H11 to emit excess  $NO_X$  emissions while the SCR unit is offline to clear up plugging.
