5. The Southern Region Hearing Board has granted the following emergency variances:

A. S-12-17E - Elk Hills Power

On April 2, 2012, Hearing Board member, John Stovall, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 8, 2012, until April 22, 2012. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4001, and 4703 and allowed for excess NO_x while performing testing and tuning on the turbine.

B. S-12-18E - Chevron USA, Inc.

On April 25, 2012, Hearing Board Chair, Hollis Carlile, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 25, 2012, until May 25, 2012. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4623 and allowed for the storage of VOC containing liquids without a functional or operating vapor recovery system.

C. S-12-22E - Aera Energy, LLC
