- A. S-13-32E - ExxonMobil Production Company

On July 8, 2013, Hearing Board Chair, Mr. William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from July 8, 2013, until July 10, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a fully functional or operating VRS.

- B. S-13-33E - Chevron USA, Inc.

On July 10, 2013, Hearing Board Chair, Mr. William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from July 10, 2013, until July 16, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a fully functional or operating VRS.

C. S-13-36E - Aera Energy LLC

On August 1, 2013, Hearing Board Chair, Mr. William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from August 2, 2013, until August 31, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2080, 2201, 2520, and 4409 and allowed field gas greater than 10% VOC by weight to enter the fuel gas distribution system.
