- A. <u>S-13-28E</u> Chevron USA, Inc.

On June 11, 2013, Hearing Board Chair, Mr. William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from June 11, 2013, until July 10, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4311, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a fully functional or operating VRS for up to 48 hours, and operation of the flare for up to one hour while CUSA conducts the appropriate repair.

## A. <u>S-13-29E</u> - Aera Energy LLC

On June 25, 2013, Hearing Board Chair, Mr. William Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from June 25, 2013, until July 24, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4409 and allowed field gas greater than 10% VOC by weight to enter the fuel gas distribution system.
