The Southern Region Hearing Board heard and granted the following emergency variances:

A. S-13-20E -Plains Exploration and Production Company

> On April 24, 2013, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 24, 2013, until April 30, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4703. and allowed the continued operation of two combustion turbine generators with excess NO<sub>x</sub> emissions.

# B. <u>S-13-22E</u> - Aera Energy, LLC

On April 25, 2013, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 24, 2013, until May 1, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4623 and allowed for the continued storage of VOC containing liquids in the subject storage tanks without an operating or functional vapor recovery system.

## C. S-13-24E - Aera Energy, LLC

On April 26, 2013, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 26, 2013, until May 9, 2013. Said variance provides relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4320, and 4409 and allows field gas greater than 10% VOC by weight and with excess  $\rm H_2S$  to enter the fuel gas distribution. In addition, it allows 56 steam generators to exceed their  $\rm SO_X$  emission limit.
