On October 14, 2013, Hearing Board Chair, Mr. William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 14, 2013, until November 12, 2013. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a functional or operating vapor recovery system.

B. S-13-53E - Chevron USA Inc.

On October 14, 2013, Hearing Board Chair, Mr. William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 14, 2013, until November 12, 2013.
