5. The Southern Region Hearing Board has recently heard and granted the following emergency variance:

A. <u>S-14-39E</u> - Chevron USA Inc.

On June 27, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from June 27, 2014, until July 26, 2014. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, 4409, and 4623 and allowed for the continued storage of VOC containing liquids in the storage tanks and the use of the loading rack without a functional and operating vapor recovery system while the leak in the vapor piping was repaired.
