5. The Southern Region Hearing Board has recently heard and granted the following emergency variances:

A. <u>S-14-30E</u> - ExxonMobil Production Company

On May 14, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from June 9, 2014, until June 11, 2014. Said variance provided relief from specific requirements of District Rules 2010, 2070.7.0, 2201, 2520, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the storage tanks without a functional and operating vapor recovery system while PG&E shuts off electrical power to the oil field.
