5. The Southern Region Hearing Board has recently heard and granted the following emergency variances:

A. S-14-24E - LaPaloma Generating Company LLC

On April 3, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 3, 2014, until May 2, 2014. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4703 and allowed for the continued operation of the gas turbine engine Unit 2 without a properly functioning fuel gas flowmeter until it can be repaired.

B. S-14-25E - Chevron USA Inc.

On April 7, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 4, 2014, until May 3, 2014. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, 2520, and 4401 and allowed for the continued production from wells served by a casing gas collection system CC-3-26C into storage tanks that are not equipped with a VRS until CUSA completes the repairs on the casing vapor recovery compressor.
