5. The Southern Region Hearing Board has granted the following emergency variances:
 - A. S-14-65E - Aera Energy LLC

On October 2, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 2, 2014, until October 31, 2014. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4311, and 4802 and allowed the vapor recovery system vapors to flow to the flare, untreated for H₂S, while the Sulfatreat vessel is bypassed.

- B. S-14-66E - Vintage Production California LLC

On October 10, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 9, 2014, until November 7, 2014. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4311, and 4623 and allowed the continued use of the flare without pilot sensing, automatic ignition, and flow measurement devices.
