5. The Southern Region Hearing Board has granted the following emergency variances since the September 10, 2014, hearing:

On September 22, 2014, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from September 18, 2014, until October 3, 2014. Said variance provided relief from specific requirements of District Rules 2070, 2201, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a functional or operating VRS while Greka repairs the vapor recovery compressor. In addition, it will allow wells with closed casing vents to produce into tanks that do not have a functional or operating VRS.
