A. <u>S-15-03E</u> - California Resources Production Corporation

On January 22, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from January 22, 2015, until February 4, 2015. Said variance provided relief from specific requirements of District Rules 2070, 1081, 2520, and 4702 and allowed for the postponement of the start-up compliance source test on the Waukesha internal combustion engine powering light oil well #72-30.
